WHAT DOES THE COMMUNITY CHOICE FINANCIAL® FAMILY OF COMPANIES (CCF) DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- account balances and payment history
- credit history and credit scores

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons CCF chooses to share; and whether you can limit this sharing. In summary, mobile information will not be shared with third parties/affiliates for marketing/promotional purposes unless we obtain the applicable consents. Information may be shared with our affiliates or third parties in support services or for transactional reasons.

What we do

How does CCF protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does CCF collect my personal information?

We collect your personal information, for example, when you:

- open an account or apply for a loan
- give us your income information or give us your contact information
- provide employment information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include companies with one of the following names: Buckeye Title Loans, California Check Cashing Stores, Cash 1, Cash Central, CheckSmart, Check into Cash, Community Choice Financial, easymoney, Speedy Cash, Rapid Cash, Avio Credit, First Virginia, U.S. Money Shops, TitleMax, TitleBucks, InstaLoan.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Nonaffiliates we share with can include both financial and non-financial companies.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners include program managers for stored value cards.*

Other important information

You may have other privacy rights in some states under state law. To the extent that such state laws apply, we will comply with them when we share information about you.

California residents: If your account has a California home address, we will not share your personal information except to the extent permitted under California law.

Nevada residents: We are providing you this notice pursuant to state law. You may be placed on our internal Do Not Call list by calling 888-314-7731.
