

FACTS	WHAT DOES SPEEDY CASH® / RAPID CASH DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>▪ Social Security number and income</li> <li>▪ Account balances and Employment information</li> <li>▪ Credit history and credit scores</li> </ul>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Speedy Cash/ Rapid Cash chooses to share; and whether you can limit this sharing. In summary, mobile information will not be shared with third parties/affiliates for marketing/promotional purposes unless we obtain the applicable consents. Information may be shared with our affiliates or third parties in support services or for transactional reasons.

<b>Who is providing this notice?</b>	Speedy Cash®/ Rapid Cash group of companies which provides various financial services such as payday loans and check cashing.
What we do	
<b>How does Speedy Cash®/ Rapid Cash protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How does Speedy Cash®/ Rapid Cash collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>▪ open an account or apply for a loan</li> <li>▪ give us your income or contact information</li> <li>▪ provide employment information</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes— information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account
Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>Our affiliates include companies that are owned by a common parent company.</i></li> </ul>
<b>Non-affiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>Nonaffiliates we share with can include direct marketing companies.</i></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>▪ <i>Our joint marketing partners include program managers for stored value cards.</i></li> </ul>
Other important information	
<p>You may have other privacy rights in some states under state law. To the extent that such state laws apply, we will comply with them when we share information about you. <u>California Residents</u>: We will not share your personal information except to the extent permitted under California law. <u>North Dakota Residents</u>: We will not disclose information about you with affiliated companies or with non-affiliated third-party parties, other than as required or permitted by law, without your express permission</p>
